**Prior Learning Credit:** Students who can demonstrate successful mastery of skills and knowledge that satisfies training at CRI will receive credit for prior learning. This will allow the student to skip specific training times and will give the student an adjustment to their tuition. Students can request up to 50% credit for any program of instruction. Evaluation for prior credit is required of all VA beneficiaries.

CRI will evaluate all documents such as post-secondary transcripts, military records and certifications to determine if the training will equate to CRI training in the program of instruction. Students may be asked to demonstrate competency in the area of prior learning before final credit is awarded. Students may also be asked to provide a copy of the syllabus or other documentation from the training facility.

A decision will be made on prior learning within two days of the submission of all requested materials and/or demonstration of competency. The student will be notified of the decision by email and by mail. It is recommended that students seeking prior learning credit make arrangements for the assessment of prior learning at least two weeks in advance of the start of the course. However, students can ask for prior learning credits at any time during the program. Adjustments to attendance for awarded prior learning credits will result in tuition adjustment.
